## Refund of Fees Submitted With a Planning Application

Provision is made for a partial refund of fees in the case of certain repeat applications where the period between the withdrawal or determination of the first application and the making of the subsequent application does not exceed one year, where the full standard fee was paid in respect of the first application and where both applications relate to developments of the same character or description and to the same site. An application for a refund must be made in writing to the Planning Authority and received by them within a period of 8 weeks beginning on the date of the Planning Authority's decision on the second application
